Congressional Delegation:


We, the undersigned
religious leaders, are
compelled to speak out at
this time. Our democratic
traditions and the
foundational sacred texts
and values of our faiths
compel us.

Our religious traditions
speak of the moral
imperative to create just
societies in which all people
are treated fairly as God's
creatures. Our accounts of
creation insist that all
people are created in the
image of God, B'tzelem
Elohim, and we must treat
every human being with

utmost care and respect. (Genesis 1:27) Our sacred legal foundations call us to love of neighbor as self, to unswerving commitment to justice, and to thorough legal process and investigations before any punitive or corrective action is taken. (Leviticus 19:18, Exodus 23:6, Deuteronomy 19:16-18) Our theologies call humans to rise above our fears and hate and to seek to imitate divine justice, mercy, and impartiality. And our prophets call us to justice and to generosity toward all people, regardless of their status or origin. (Isaiah 1:17; Quran, 16:90, 2:177, Matthew 25:3-46)

While we are a pluralistic, secular society, we believe that we are our healthiest, best, and most just society when these timeless, sacred, self-evident values are honored within our democratic processes and traditions. Our founders agreed.

As residents of Massachusetts, we just commemorated the 250th anniversary of the start of our American Revolution on April 19, 1775. Our predecessors fought here for freedom, documenting their call to democratic rather than tyrannical rule in the Declaration of Independence. Our Constitution endeavors to protect human rights and dignity through its commitment to due process of law for all persons within our borders, as enshrined in the Fifth and Fourteenth Amendments.



Current circumstances call us to stand with the ancestors in our faiths and the founders of our country and stand for the protection of human rights, due process, generosity, and justice in the enforcement of law.

The current Federal administration's assaults on human dignity, due process, and justice are too many to cite. However, they include the following:

- Numerous executive orders have been blocked by the courts, including one to end birthright citizenship in violation of the clear language of the 14th Amendment. Yet unconstitutional actions, abuses of power and neglect of due process persist.
- A resident of Maryland, Kilmar Abrego Garcia, was detained and deported to El Salvador, though he had been granted “withholding of removal” by an immigration judge. After acknowledging his deportation was due to administrative error, the administration has refused to facilitate his return.
- United States born citizen children have been deported with their foreign-born mothers, without sufficient due process.
- Boston-area graduate student Rümeyisa Öztürk had her student visa revoked without notice, was detained, and is threatened with deportation for no reason other than exercising her right to free speech.
- In an act of judicial intimidation, a Wisconsin State judge was handcuffed, shackled, and arrested in her own courtroom, a severe violation of judicial independence and the separation of powers, which is a hallmark of our constitutional system.
- Executive orders are attempting to forbid law firms from entering federal buildings, reducing access to representation, and eroding due process unless the law firms pledge fealty to the administration.
- Breaking with precedent, the Department of Homeland Security has rescinded its sensitive areas policy, violating the sacred space of religious institutions and jeopardizing the safety and public health of our communities by encouraging some American residents to avoid areas such as courts, public schools, houses of worship, and health care centers.
- In a widely aired public interview, the President has stated that he does not know if American citizens should receive due process and that he does not know if he needs to uphold the Constitution.

As federal judges have concluded, these actions show contempt for due process, freedom, and Constitutional rights. They also undermine sacred values that guide our faiths and uphold our communities. History shows us that governments that violate law, custom, and morality will continue to do so, with greater and greater damage done to our lives and our democracy.

In the name of God and in the name of justice, we call upon our Congressional delegation to act boldly and consistently in your duties to provide oversight and accountability to this administration. We also specifically call upon you to co-sponsor and support the Protecting Sensitive Locations Act (HR 5166 and S455), which would

respect the separation of church and state and the freedom of religious assembly by limiting immigration enforcement activity in and around sensitive locations.

We also call upon religious leaders around the country, and all our fellow Americans, to join us in calling for our President to obey the law and to respect the decisions of our courts and the rights of all American residents.

In our faith traditions and our American tradition, the President is not a dictator or tyrant. Instead, “the Law is King, and no person is above the law.” (Thomas Paine, Common Sense)
